Dear Parent:

This is your Parent Admission/Commitment Agreement for childcare services.

Your signature on this form indicates that you have read and agree to abide by the Parent Admission Agreement. We look forward to having your child registered and using the services at TodayCare at the Social Security Child Development Center in Birmingham.

Tuitions for all programs are listed below and will be in effect until December 31, 2022, and a new Parent Admission Agreement is signed. You will be given 30-day written notice when a tuition increase will occur. Reservation agreements must be cancelled 30-days prior to the last day of care or you will be billed the full rate of tuition. You may not schedule your child for care if your tuition fees are not paid. Tuition is payable monthly per ACH withdrawal or bi-weekly via payroll deduct and must be paid in advance. The registration fee is \$100 per child or \$150 per family paid in advance and non-refundable.
